

What is GAMMAGARD LIQUID?

GAMMAGARD LIQUID is a ready-to-use liquid medicine that is given in a vein (intravenously) to treat multifocal motor neuropathy (MMN) in adults.

Finding your new normal

Having MMN means your "everyday" has changed. Activities that seemed automatic before may have become harder, such as texting a friend, using utensils, or tying shoelaces. In short, you've had to redefine how you live your life.

You can decide what MMN means for you

The road to finally getting diagnosed may have been long and uncertain, and you may be wondering what's next. Diagnosis can bring relief—there's good news that comes with finally knowing what you have.

- While it's not curable, MMN is treatable
- Treatment with GAMMAGARD LIQUID in clinical trials was shown to help improve or maintain muscle strength and functional ability



What is GAMMAGARD LIQUID?

GAMMAGARD LIQUID is what's known as an Ig, or IVIg, therapy. Immunoglobulin (Ig) refers to antibodies, an important part of the body's immune system. GAMMAGARD LIQUID is healthy Ig that's collected from human donors and administered through an intravenous (IV) infusion—that's why it's referred to as IVIg.

IVIg treatment is the most commonly used treatment for MMN.

Why use GAMMAGARD LIQUID?

GAMMAGARD LIQUID is the first and only FDA-approved treatment for MMN and was shown to help with everyday tasks, such as tying your shoes, personal grooming, and working a zipper or buttons.

Together with your doctor and healthcare team, you can actively treat your MMN to help redefine how it affects your life.

Who should not use GAMMAGARD LIQUID?

Do not use GAMMAGARD LIQUID if you:

- Have had a severe allergic reaction to immune globulin or other blood products.
- Have a condition called selective (or severe) immunoglobulin A (IgA) deficiency.

What should I avoid while taking GAMMAGARD LIQUID?

- GAMMAGARD LIQUID can make vaccines (like measles/mumps/rubella or chickenpox vaccines) not work
 as well for you. Before you get any vaccines, tell your healthcare provider (HCP) that you take GAMMAGARD
 LIQUID.
- Tell your HCP if you are pregnant, or plan to become pregnant, or if you are nursing.

Reestablish your routine



Improving your strength is possible

GAMMAGARD LIQUID was shown to help people with MMN improve and maintain areas of muscle strength that relate directly to your everyday.

In the largest clinical trial in MMN to date, GAMMAGARD LIQUID was shown to*:

Improve grip strength

Reduce disability

GAMMAGARD LIQUID was also shown to maintain dexterity in the hands.

Understanding possible side effects can help you plan ahead for treatment

Knowing the possible side effects of any medication is important when considering treatment.

Most common side effects

- Headache
- Muscle spasms
- Nausea
- Ear pain

- Chest discomfort
- Muscular weakness
- Sore throat
- Pain in hands or feet

These are not all the possible side effects. Talk to your HCP about any side effect that bothers you or that does not go away.

What are the possible or reasonably likely side effects of GAMMAGARD LIQUID?

GAMMAGARD LIQUID can cause serious side effects. If any of the following problems occur after starting GAMMAGARD LIQUID, stop the infusion immediately and contact your HCP or call emergency services:

- Hives, swelling in the mouth or throat, itching, trouble breathing, wheezing, fainting or dizziness. These
 could be signs of a serious allergic reaction.
- Bad headache with nausea, vomiting, stiff neck, fever, and sensitivity to light. These could be signs of irritation and swelling of the lining around your brain.
- Reduced urination, sudden weight gain, or swelling in your legs. These could be signs of a kidney problem.
- Pain, swelling, warmth, redness, or a lump in your legs or arms. These could be signs of a blood clot.
- Brown or red urine, fast heart rate, yellow skin or eyes. These could be signs of a liver or blood problem.
- Chest pain or trouble breathing, or blue lips or extremities. These could be signs of a serious heart or lung problem.
- Fever over 100°F. This could be a sign of an infection.

You and your doctor can choose where you get your infusions

You'll likely have your first infusion at a hospital or an infusion center. People who choose to get their GAMMAGARD LIQUID treatment at home usually do so because they want flexibility or have transportation issues. When deciding where to get your infusions, ask yourself:

- . How far away is the clinic?
- . How often will I have to receive treatment?
- Would I prefer to receive my treatments in private?
- Am I comfortable having a nurse come to my home?
- What location best fits my lifestyle?

When in doubt, speak out

Make sure you understand your doctor's recommendations for your treatment plan. Don't be afraid to ask guestions and make your personal preferences known. This will help ensure you and your doctor come up with the best plan for you.

Receive your treatment



Now you're ready for your first infusion

Everyone's experience is unique, but in general the process involves having an IV catheter inserted into one of your veins for an hour or more. Here are some things you can do to make the best of your infusion experience.

Before

- Plan ahead to ensure your infusions fit your schedule
- Take note of the guidance provided by your doctor or nurse as they walk you through the process
- Drink plenty of fluids
- Bring a book or other things to keep yourself occupied

During

- Get comfortable! Try to relax by reading a book or listening to music or podcasts
- Follow any directions from your infusion nurse, who will check your vital signs to make sure you are doing ok
- Make sure to tell the infusion nurse if you're experiencing any reactions or discomfort

After

- Continue to stay hydrated
- Record your infusion experience
- Follow up with your healthcare team routinely
- Inform your doctor about any side effects that bother you or do not go away

When will I feel results?

Results with any medication vary. For some people, results can be seen relatively quickly. For others, positive results can take longer to occur or may not be seen.

How long will I take GAMMAGARD LIQUID?

GAMMAGARD LIQUID is a long-term treatment, which means that in order to maintain results, you may need to continue to receive infusions. Your treatment approach and schedule may change over time to manage your symptoms and needs.





Understanding insurance coverage is key to starting and continuing treatment

Specialty pharmacies can play a key role

If you and your doctor decide you should receive your GAMMAGARD LIQUID treatment at home, a specialty pharmacy will be an important part of your network.

Your specialty pharmacy will send a nurse to your home to administer your infusions. They'll also verify your information and medication history, as well as go over safety information and make sure you are getting the right dose, as prescribed by your HCP. Additionally, they will oversee your progress with your doctor and also help you navigate insurance and financial matters, if necessary.
